Approximately **3%** of the resident population are unable to or had some difficulty performing at least one basic activity.



Persons with physical disabilities constitutes half of the disability group. The remainder comprises those with sensory or intellectual disabilities and autism spectrum disorder.



About **7,000 children** are diagnosed with developmental needs such as autism and language development delays in Singapore every year.



In 2022, there are **27,000 students** with mild special education needs in mainstream schools, while **7,000 students** are in SPED schools.



Only **3 in 10** persons with disabilities who are of working age are employed.



Singaporeans are living longer but will spend **3 to 8 years** of their lives with some form of disabilities.

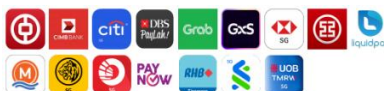
